1. Rent & Due Date. Renter agrees to rent the above described instrument, case and bow (hereinafter collectively referred to as the "Instrument") on a month-to-month basis for a minimum of three months at the rate of \$ _____ (plus tax) per month, payable in advance, with no partial months offered. Payment is due on the _____ of each month (start date of rental is the day that the instrument leaves the shop).

2. Automatic charge of current rent. Renter authorizes Bernstein Violins to charge current rental payments to Renter's charge card as follows: **VISA\MasterCard\Discover #** _____ **exp. date:** _____. Renter agrees to maintain the credit card in active status until the termination of this agreement and all rent, fees, and costs are paid, and renter agrees to advise Bernstein Violins promptly of any change in card (i.e. exp. date or account number). _____ (initial).

3. Loss, damage and subsequent repair. This Instrument is rented in good condition. Renter agrees to return the Instrument in the same condition as when rented. Renter agrees to pay the cost of all maintenance (such as string and bridge replacement, bow rehair, etc.) and for **any** loss or damage to the Instrument, regardless of cause, which occurs during the rental. This includes, but is not limited to, loss or damage caused by fire, theft, vandalism, neglect, or accident. Renter agrees to notify Bernstein Violins immediately of any loss, theft, or damage to the Instrument. Rental Instruments are NOT insured by Bernstein Violins. **Renter shall not attempt to make any repairs to the Instrument or take the Instrument to any other repair shop for repairs without the prior approval of Bernstein Violins.** _____ (initial).

4. Change in employment or residence. Renter agrees to notify Bernstein Violins of any change in employment or residence. Renter agrees not to take the Instrument away from the residence listed above for an extended length of time without prior consent of Bernstein Violins.

5. Converting rental to purchase. There is no time limit on the rental. Renter may rent the Instrument indefinitely. This rental may be converted to a purchase at any time while renting at Renter's request solely upon the execution of a purchase & security agreement between Renter and Bernstein Violins. In the event of a purchase, half of the monthly rental payments will be allowed as a credit toward the purchase, and may be applied to the purchase of the Instrument (complete outfit), or to an instrument, case and bow that is of greater value than the rental Instrument.

6. Shipping Charges (when applicable). Renter agrees to pay shipping charges to and from the shop of Bernstein Violins. Instruments are to be returned via United Parcel Service or Federal Express, prepaid, and insured for the full value. (The value is on the rental contract.)

7. Termination & Interest charges. Renter may return the Instrument at any time. Return of this Instrument terminates this agreement, however, Renter is not entitled to refund of any rent paid, and remains liable for all past due rent, late fees, and ANY damage to the Instrument incurred during the rental. All rent and fees not paid within 30 days of return of the Instrument will be subject to an interest charge of 1.5% per month.

8. Return of Instrument to Bernstein Violins, collection costs. The Instrument is and will remain at all times during the rental the property of Bernstein Violins. **Renter agrees to return the Instrument to Bernstein Violins immediately upon demand.** Should Renter violate any term or condition of this Agreement, Renter will immediately return possession of the instrument to Bernstein Violins. Renter further agrees to pay all costs incurred in the collection of past due rent, fees and damage or replacement charges, including reasonable attorney fees.

9. It was explained to me how to take care of the bow and instrument, including the importance of keeping the bridge straight, and I understand that full replacement charges for warped bridges will apply. I also understand that broken strings must be replaced with the same brand and size of string that is on the instrument, and that full replacement charges will apply for an instrument returned with strings that do not match the original strings put on by Bernstein Violins _____ (initial).

10. It is the responsibility of the Renter to make sure that no medical or velcro adhesives shall applied to the Instrument, including but not limited to moleskin, corn pads, gel pads, medical tape, etc. Only removable tape may be used, and only on the fingerboard and bow stick.

I have read and understand all of the terms of this Agreement. I understand that this writing constitutes the entire agreement, and that there are not terms or conditions not contained herein..
